Dhamecha Foods Limited is a company registered in England and Wales, it is a family-owned business and has ten depots around London and the Midlands, whose core business is supplying a comprehensive range of products to Independent Retailers.

All are open seven days a week and all stock over 12,000 products across the following key areas: Grocery, Soft Drinks, Confectionery, Toiletries & Household Goods, Wines & Spirits, Beers & Ciders and Tobacco.

Dhamecha Foods Limited is also the largest member of Unitas Wholesale Limited, which is the UK's largest food and drink wholesale buying group.


- identify and assess potential risk areas in Dhamecha Food Limited's supply chains

- mitigate and eliminate the risk of slavery and human trafficking occurring in Dhamecha Food Limited's supply chains
- protect whistle-blowers

**In the financial year ended 31 March 2021, Dhamecha Food Limited has continued to enhance its supply chain compliance programme by:**

- monitoring compliance by requiring customer-facing or supplier-facing employees of Dhamecha Food Limited to review and confirm their compliance with our Legal Code of Conduct every year;
- training relevant employees who have responsibility for our supply chain and procurement about the risk and process for ensuring there is no slavery and human trafficking within Dhamecha Food Limited's supply chains;
- ensuring Dhamecha Food Limited has suitable contractual undertakings from our third-party suppliers as to their compliance with the law in this area; and
- having a dedicated compliance team which consists of professionals from Legal, Finance, Human Resources and Procurement.
